■BEWARE OF TAX FRAUD



How will I know if a fraudulent tax return was filed in my name? You probably won't know you've been a victim of this type of fraud until you or your tax preparer attempt to e-file your legitimate tax return. Your return will be rejected for e-filing because the IRS records will show that your return has already been filed.

How can someone file a fraudulent return without access to any of my tax documents? A thief needs only your name and Social Security number to file a fraudulent return. Even if your address, number of

dependents, marital status, and income/expense details are incorrect, the IRS will accept the fraudulent return and, in many cases, issue a refund to the address or to the bank account/debit card shown on the fraudulent return.

What should I do if a fraudulent tax return was filed in my name? You will have to paper-file your tax return. Use Form 14039, Identity Theft Affidavit, as a cover sheet for your return, and attach a photocopy of your passport, driver's license, or Social Security card as verification of your identity.

How big is this problem? The Treasury Inspector General for Tax Administration's report in May 2012 said that approximately 641,000 taxpayers were affected by identity theft in calendar 2011. This is more than double the number affected in 2010. The IRS makes every effort to process tax refunds as quickly as possible by verifying the information submitted at a later time. Unfortunately, this is the crux of the problem.

If you are the victim of this type of identity theft, and you are due a refund, your refund could be tied up for months. In addition you must be alert to the possibility of other improper uses of your personal information.

What can I do to prevent being victimized? The IRS encourages taxpayers to guard their personal information. Leave your Social Security card at home unless you must physically produce it for a legitimate purpose. Ask service providers, such as medical establishments and educational institutions, if your SSN must be provided in order to receive services, and if so, how your personal information will be safeguarded. While this is a valid suggestion, most taxpayers have already given their personal information to employers and service providers countless times.

The IRS recommends that taxpayers file their returns as soon as they've received all of their tax documents, in an effort to preempt any fraudulent activity. You may also want to contact your elected representatives to encourage them to address this serious and growing problem.
